

Instructions for Voting for Board of Directors

Vote for up to 6 of the candidates listed on the other side of this form. NOTE: No more than two members from each state may serve on the board of directors at the same time. Board roster indicates which states are currently represented.

If you prefer to let a member present at the annual meeting vote on your behalf, fill out and sign the Proxy Statement on this side. You may either vote or you may assign your proxy--you cannot vote for some candidates and assign your proxy for the rest. Remember, you may vote for up to 6 candidates, but you need not cast all 6 votes. When you have voted,

sign your ballot and mail it in the enclosed return envelope to IRES. Your mail-in ballot will not be valid without your signature. If you plan to attend the IRES Seminar, you need not return this ballot now. You may vote in person at the membership meeting.

All ballots, including proxies, mailed to the IRES office, must be received at least five (5) days before the scheduled start of the annual meeting. All ballots and proxies delivered in person must be received by 4:00 p.m. local time on the day before the scheduled start of the annual meeting.

Proxy Instructions

If you will not be attending the 2010 Insurance Regulatory Examiners Society's Annual Meeting in Albuquerque, then you may vote by mail — or you may assign your proxy to another member who will be present at the meeting. If you choose to vote by proxy, name the member to whom you wish to assign your proxy and sign below. If you choose to sign the Proxy

Statement do not go any further. Do not mark on the ballot form on the reverse side, as your proxy will cast these for you. Proxies may be withdrawn or modified by the voting member by written notification to the Society's office five (5) days prior to the meeting, or by the voting member in person no later than 4 pm local time on the day before the scheduled start of the annual meeting.
