SUBMISSION INFORMATION

If you are interested in speaking, either alone or with others (panel discussion), submit your information below with the title and a detailed description of your presentation, and a short bio here by **December 15, 2025.**

You should be prepared to provide the following information before starting your submission.

- Title of the proposed presentation.
- A detailed description of the proposed presentation (up to 600 characters)
- Is the presentation a solo presentation or presented as a panel?
- The name of each proposed speaker.
- · Designations for each proposed speaker.
- Whether each speaker is an IRES Member.
- Please provide the name of your company or organization (for each presenter)
- Please provide an email address for communications (for each presenter)
- Provide three (3) learning objectives your presentation will achieve
- · Please indicate if you agree to be recorded.
- If you are unexpectedly unable to present your presentation, do you plan to provide your own replacement for the same presentation? If the answer is yes, provide the name of the backup speaker.
- Be prepared to attach biographies for all known presenters.

A few tips for your submissions:

- The information provided through this form will be used by the CDS Committee to objectively select those speakers that will comprise the CDS Agenda.
- A separate form must be completed for each presentation being proposed.
- Submissions for panel discussions involving more than one speaker should be submitted by a single presenter.
- Incomplete applications will not be accepted. Late applications may be accepted on an as-needed basis.
- Biographies and photos of presenters are required at the time of submission.
- · A confirmation email will be sent upon successful completion of the online form.

SELECTION INFORMATION

Speakers will be selected by IRES's CDS Program Committee. IRES Membership may be considered when selecting speakers. Speakers will be notified that they have been selected to present at the IRES Career Development Seminar no later than **December 15, 2025.**

Note that we anticipate more topic submissions than available breakout sessions. For this reason, some individuals may be notified they are identified as an alternate CDS presenter, which means you may be asked to fill in should another presenter be unavailable for a session. If you are notified your session was not selected, there may also be opportunities presented for a future webinar presentation through the IRES Education Committee.
